The Commission Welcomes New Members

On October 7, President George W. Bush named representatives from the four border states to serve as members of the U.S.-Mexico Border Health Commission. The Commission extends a warm welcome to these new members and looks forward to a productive and successful working relationship. The new members attended an orientation in Washington, D.C. in early November, where they were provided an overview of the Commission. The new members are:

Emma Torres, who has been a strong border commu-

nity leader and a health advocate for migrant and seasonal farm workers in Western Arizona for more than 20 years. She is a co-founder of Campesinos Sin Fronteras, a grassroots, community-based organization, and is one of the pioneers of the *Promotora* model program in Arizona. Presently, Ms. Torres serves as the vice-president for the Sunset Community Health Center Board of Directors. For her leadership, Ms. Torres has been recipient of various recognitions and awards. In 1999-2002 she received the Robert Wood Johnson, National Leadership Award, the Orgullo Hispano and the U.S.-Mexico Border Health Association's Health Care Worker of the year.

Dr. Lawrence Kline, D.O., originally from Hazleton, Pennsylvania, is the medical director of the Scripps Clinic Sleep Center in La Jolla, Calif., and an associate adjunct professor in the Department of Molecular and Experimental Medicine of the Scripps Research Institute. Dr. Kline is a graduate of Temple University and the Philadelphia College of Osteopathic Medicine. He served with the U.S. Public Health Service as the director of intensive care and as assistant chief of staff of medicine in

USMBHC Binational Meeting held in Laredo

The Commission's Binational Meeting took place in Laredo, Texas on September 12. Rear Admiral Richard Walling called the meeting to order. The main order of business was the approval of the FY 2004 Work Plan and Budget, but due to a lack of quorum, the Commission members present voted to accept the budget with recommendations. The recommendations were ratified by the absent members on September 19.

In other business, Walling informed Commission members on the status of the application for Public International Organization. He stated that after the State Department clears the document, it would go to the Office of Management and Budget, and it is hoped that the process would be completed by the end of December.

Members were also updated on the Global Security for Early Warning Infectious Disease Surveillance Project. Funding in the amount of \$5.4 million has been

made available by the Department of Homeland Security to the U.S. Department of Health and Human Services to be allocated to the Commission and the border region to build infrastructure. The scope of work is in place and will be followed by an implementation plan in the near future. Secretary Thompson will be making the official award announcement at the 4th Annual Binational Meeting.

It was also reported that the compendium for the Border Models of Excellence has been completed in English and Spanish, and it is being utilized as a tool for the duplication of the award-winning projects.

Other events attended by Commission members included:

- Los Dos Laredos 7th Annual Binational Health Conference.

Binational TB Case Management Project


The project, which was launched on March 27, 2003, as part of a World TB Day celebration in El Paso, Texas,

has made great strides in the implementation of its protocols and the binational health card.

As of October, several pilot sites on both sides of the border have received training and are distributing the binational health card. In the United States, the pilot site of El Paso/Las Cruces has distributed 33 cards, and in San Diego, 89 cards have been distributed.

In Mexico, Ciudad Juarez has distributed 48 cards. In the Tijuana pilot site 153 cards were distributed, and in Matamoras, 200 cards were distributed.


Other pilot sites on both sides of the border have either received training and are in the process of card distribution or will undergo training over the next few months.

The CDC conducted initial site visits at the U.S. pilot sites in May and July. The National TB Program and the CDC will conduct site visits in Mexico in November. An all partners progress meeting is planned for the week of Jan. 19,

Both countries see the establishment and implementation of the Binational TB Case Management Project as a critical step in responding to the health crisis of tuberculosis in this region. If the project proves successful, the goal is to extend it to all of the United States and Mexico.

Department of Energy **Partnership**

The Commission has entered into a partnership with the Department of Energy's National Border Technology Partnership Program (NBTPP). The NBTPP deploys technology throughout the U.S.-Mexico border region as a means to reduce and better manage hazardous materials that threaten the region's public health and safety.

The Commission will be collaborating with the Applied Sciences Laboratory (ASL) in Albuquerque, NM, in an effort to deploy technologies that will have the greatest potential impact on improving the border region's public health and safety. The USMBHC will ascertain health and safety issues problem areas, while ASL will pursue technologies that can be deployed to help solve them. Additionally, the NBTPP will provide support for the continued development of the Commission's GIS Healthy Border Mapping Service.

BIDS Conference held in Cuernavaca

In 1997, the U.S.-Mexico Border Infectious Disease Surveillance Program (BIDS) was established in collaboration with the United States and Mexican border

counties and states, the Mexico Secretariat of Health and Centers for Disease Control and Prevention.

BIDS has established a network of epidemiologists and laboratories that contributes infectious disease surveillance data to provide epidemiologic information on diseases of mutual public health importance in this unique binational setting. The network includes Mexican federal, state and local epidemiologists and their U.S. counterparts in the border region. BIDS has been a catalyst in the planning for preparedness for emerging infectious diseases and early

warning of possible bioterrorism-related events on this most highly crossed international frontier in the world.

The project currently includes 16 clinics and hospitals in 12 cities on both sides of the border. The fourth annual BIDS border wide conference was held in Cuernavaca, Mexico, in September 2003. In addition to bioterrorism and West Nile Virus, topics

discussed included control of measles in Mexico City, parasitic diseases of binational importance, internetbased disease reporting, and the development of the



U.S.-Mexico Border Health Commission's geographic information system.

The Commission is partnering with BIDS in channeling funding for border surveillance activities in Mexico, fostering early warning for bioterrorism-related syndromes in the border region, and establishing a quality control system for BIDS border laboratories.

· Healthy Border 2010: An Agenda for Improving Health on the United States-Mexico Border- After several months of collaborative and binational work, the Commission is pleased to announce the electronic publication of Healthy Border 2010: An Agenda for Improving Health on the United States-Mexico Border. This significant report outlines the 10-year bilateral agenda for the Healthy Border Program, providing year 2000 baseline data and year 2010 targets.

The Healthy Border Program establishes 10-year objectives for binational health promotion and disease prevention in the border region, based on common health indicators from the United States and Mexico.

The printed form of the publication is currently in production and will be available by the end of November. State Outreach Activities

- The New Mexico Outreach Office, in conjunction with the Southern Area Health Education Center, held a luncheon on October 2 at New Mexico State University, Las Cruces, to recognize the New Mexico programs that received the Border Models of Excellence Award.
- The states of Arizona and Sonora joined forces to offer the first-ever joint childhood immunization program. The program got underway on Saturday, June 7, in San Luis Rio Colorado, Sonora. The campaign coincided with the annual three-week immunization program in Mexico. In Yuma, Ariz., health officials decided to hold a special week beginning that Saturday to correspond with the Mexican campaign. It's estimated that as many as 80,000 children received free inoculations.
- Through the bilateral and collaborative efforts of more than 300 organizations from the United States and Mexico, the states of California and Baja California presented the third annual Binational Health Week, a series of health promotion and education activities, from October 11-19, 2003. Activities were conducted across 22 California counties and eight Mexican states. During the week, the Third Binational Policy Forum on Migration and Health was held at the University of



California, Los Angeles, on October 16-17. Legislative representatives from California and Mexico, state agency directors, union leaders and key stakeholders convened to discuss migrant and immigrants' health challenges, and to explore the opportunity of working collaboratively to improve the health and well-being of the migrant population.

• Health officials from the 10 border states convened at a binational workshop on the Prevention and Control of the West Nile Virus, on September 10 in Nuevo Laredo, Tamaulipas. The objective of the workshop was to establish collaborative, binational efforts to detect, prevent and control the outbreak of the West Nile Virus.
