Relay For Life (RFL) is the American Cancer Society's signature event, taking place across the nation and in countries around the globe. In fact, it is the largest annual non-profit fundraising event in the world! It brings together 3.5 million people to celebrate the lives of those who have battled cancer; remember loved ones lost to the disease; and raise money for cancer research, education and prevention programs. In 2008 RFL took place in 313 communities and raised an estimated \$36.5 million in California.

Relay For Life is a high-spirited, 24 hour team event where teams of up to 15 people take turns walking and running around a field to raise funds for the American Cancer Society. The event itself is like one big, family-friendly community party. This year, a Relay For Life will take place in Southeastern San Diego under the leadership of Ms. Diane Moss and Project New Village.
